



# **Executive Summary**

Vidant Beaufort Hospital is a not-for-profit, community hospital located in Washington, NC. The hospital is part of Vidant Health; a regional health system serving 29 counties in eastern North Carolina. The hospital has served Beaufort and surrounding counties since 1958. The health system's mission, "to improve the health and well-being of eastern North Carolina" drives a system of care for healthier communities beyond the traditional walls of our facilities.

# **Description of Community**

The primary service area for Vidant Beaufort Hospital includes Beaufort and mainland Hyde Counties, North Carolina. Surroundingcities and towns include Washington, Aurora, Bath, Belhaven, Pantego, Chocowinity and Washington Parkin Beaufort County and Ponzer, Swan Quarter, Fairfield and Engelhard in Hyde County. According to the 2010 Census, Beaufort County has a population of 47,759. Over 68% of the population is white, followed by 25% black, 7% Hispanic. Less than 1% consider themselves American Indian or Asian. The 2010 Census reports a population of 5,810 in Hyde County. 64% of the population is white, 31% is black, and 7.1% is Hispanic. Less than 1% consider themselves American Indian or Asian.

In Beaufort County, statistics indicated vulnerable populations as:

- Persons living below the Federal Poverty Level. Twenty-one percent of the population is living inpoverty.
- · Children under the age of five years. Twenty-nine point three percent of children less than five years of age are considered overweight or obese.
- Persons of the African American race. African-Americans have a higher incidence of cancer as well as higher mortality rates for heart disease, cerebrovascular disease, diabetes mellitus and Alzheimer's disease.

In Hyde County, populations at risk for poor health outcomes include:

- People without a medical home: low medical provider ratios and utilization of area hospital emergency departments for health care are indicators that many in Hyde County do not have a stable medical home.
- The growing elderly population: there is an apparent lack of nursing home and assisted living housing options for the elderly as they reach the point they can no longer care for themselves.
- Uninsured or underinsured Hyde County residents: these populations have difficulty accessing health care.
- Males: men suffer mortality and morbidity at higher rates than females.
- People without reliable transportation: the elderly and poor, especially, have limited transportation
  options to access the limited health care in large, predominately rural Hyde County.

Minority populations: this population group suffers the consequences of poverty and limited health care access at the highest rates.

#### Who Was Involved

The community health assessment process was a collaboration between the health departments in both Beaufort and Hyde counties and Vidant Beaufort Hospital. To ensure input from persons with a broad knowledge of the community, organizations representing the counties in sectors such as mental health, children's health, and senior health services participated in the process. Additionally, individuals from agencies representing the uninsured and underinsured were invited to participate.

Those who committed to the assessment and planning process became the stakeholder group and attended meetings beginning in the summer of 2014 for both counties respectively. Finally, partners from Vidant Beaufort Hospital, the Beaufort and Hyde County Health Departments, and East Carolina University formed leadership teams, which worked collectively to identify the types and sources of data to be collected and along with the stakeholder group, helped prioritize the

Both counties collected primary data with the use of a community survey and by conducting focus groups. Stakeholder groups in both counties were invited and participated in a priority setting worksession. The following groups were represented during the process of this assessment:

#### 2016 Update and Amendment

The 2015 Community Health Needs Assessment (CHNA) for Vidant Beaufort Hospital has been updated and amended to serve as the Community Health Needs Assessment for 2016-2019. This update and amendment was completed to align the Vidant Beaufort Hospital CHNA timelines with the eastern NC regional CHNA, targeted for completion in 2019.

Vidant Beaufort Hospital completed its most recent CHNA in 2015. The 2010 Affordable Care Act (ACA) requires all 501(c)(3), tax-exempt hospitals to conduct a community health needs assessment every three years. In order to remain in compliance with these federal requirements, Vidant Beaufort Hospital is required to complete an assessment prior to 2019, when the regional CHNA is scheduled for completion. Therefore, the decision was made to update the 2015 assessment at this time. This was the most cost effective option for updating, as secondary data analyses had been completed for Vidant Beaufort Hospital as a component of the CHNA process completed for all other Vidant Health hospitals in 2016.

The 2016 Beaufort County and Hyde County CHNAs will include primary data collected from community members in 2015 and secondary data, as current as March 2016. A review of the primary and updated secondary data identified the same health priorities as identified and approved in 2015.

Therefore, Vidant Beaufort Hospital will continue to focus on the same priorities identified and approved in 2015 for the 2016-2019 time period.

# VidantBeaufortHospital'sCommunityBenefitGrantsProgram

Vidant Health wants to do more for people to improve their health before they reach the point of having to be hospitalized. That's why in 1998, Pitt County Memorial Hospital (now Vidant Medical Center) made a substantial donation to the Pitt Memorial Hospital Foundation (now Vidant Health Foundation) to establish the Community Benefit and Health Initiatives Grants program. In 2006, the program extended its outreach by establishing a Regional Community Benefits Grants program which works with Vidant Health regional hospitals to distribute grants to their communities. The goal of the program is to support outreach projects that focus on wellness and prevention strategies. The Community Benefit Grants programe ducates people about disease prevention and management, provides people with the knowledge and tools to be successful in their own health care and locates programs within communities, making them available and more accessible to people needing the programs/services.

Vidant Beaufort Hospital has a committee of community members from Beaufort and Hyde counties to review the health needs of our community and determine focus areas for our participation in this program. The committee's current focus areas based on the 2015 CHA include:

- Chronic Disease Preventionand Management
- · Access to Care
- · Physical Activity and Nutrition

Vidant Beaufort Hospital distributed \$97,600 to various agencies in Beaufort and Hyde counties in July 2016. The next funding cycle will align the Community Benefit Grant focus areas with the health priorities identified in the 2016 CHA.

Vidant Beaufort Hospital's Community Health Implementation Plan is based on the findings of the community health assessment as well as the focus areas established for our community benefit activities.

# Implementation Plan

# Initiative: Chronic Disease Prevention and Management

**Goal:** To improve outcomes and quality of life for adults with chronic illness (i.e. diabetes, heart disease, stroke).

## Strategies:

#### 1. Screening

- Provide screenings in Beaufort and Hyde counties for early detection of heart disease, stroke and diabetes in adults.
- Conduct annual free community health fair in May in conjunction with National Hospital Week, offering cholesterol, blood sugar, blood pressure, height/weight and body mass index screenings for participants.
- · Partner with the Beaufort County Health Department in its annual 411 Health Fair.
- Partner with Beaufort County Community College to support their BEAU-FITT program by providing pre- and post- wellness screenings.
- Partner with Hyde County Health Department to plan community health events and screenings such as their annual community Open House.

#### 2. Health Education for Prevention

- Provide health education to prevent chronic disease at health fairs, educational events such as Knowledge is Power, community seminars, clinical speaking engagements or at major health events including:
  - a) Pink Power breast cancer awareness event October
  - b) Heart Truth women's heart health awareness event February
  - c) Colon Cancer Awareness March
- Provide a health event team to represent the hospital and physician practices at community health fairs and events in the Beaufort and Hyde County areas to perform health screenings, promote health education, provide information about risk factors and provide information about resources and services to treat chronic disease.
- Provide community education about a variety of health topics including chronic disease prevention and management through a Health Beat column in the local newspaper.
- Provide editorial content for quarterly Healthy Living publication that is distributed by the local newspaper. Topics are focused on exercise and wellness, technology, senior living and breast cancer awareness.
- Utilize social media to provide information to the community about a variety of topics related to chronic disease prevention and management.

- 3. RehabilitationandExercisePrograms
  - Provide cardiopulmonary rehab programs for heart disease and COPD patients at Vidant Wellness Center.
- Provide support and/or funding through our Community Benefit Grants and Health Initiatives
  program and other community partnerships that focus on chronic disease prevention and
  management.
  - · Mid-East Commission Belhaven Healthy Aging Community program
  - Hyde County Health Department Healthy Hyde program
  - Beaufort-Hyde/Pantego Community Center Growing a Fit community program
  - · Albemarle Commission Senior Nutrition program (Meals on Wheels) Hyde County
  - · Beaufort County Boys and Girls Club Washington and Belhaven
  - · Eagles Wings Healthy Food Choices by Example

- Our Community Health Improvement Coordinator, a Registered Nurse, will continue to plan, organize and oversee community health fairs / free wellness screenings and to be a liaison between our hospital with churches, schools, health departments and civic organizations to seek opportunities to share ways to improve overall community health and wellness.
- 6. Continue participation in the HealThy Neighbor faith health partnerships with localfaith organizations in Beaufort and Hyde Counties to promote healthy lifestyles and to provide health education.

# Initiative:Cancer

**Goal:** To improve prevention and early detection of cancer as well as improve the outcomes and quality of life for adults with cancer.

#### Strategies:

- 1. Screenings
  - Provide screenings in Beaufort and Hyde Counties for early detection of breast and skin cancer in adults.
  - Implement breast cancer awareness project to screen women for breast cancer annually during the month of October at physician practices/community centers; provide clinical

breast exams and referrals for mammography. Partner with the local health departments Breast and Cervical Cancer Control Programs (BCCCP) to provide financial assistance for mammograms to those who qualify.

- 2. Education for Early Detection and Prevention
  - Provide education to the community about early detection and prevention of cancer at health fairs, educational events such as Knowledge as Power, Shepard Lunch and Learns, community seminars, clinical speaking engagements or at major health events including:
    - a) Prostate Cancer awareness September
    - b) Ovarian Cancer awareness September
    - c) Pink Power breast cancer awareness event October
    - d) LungCancerAwareness-November
    - e) Colon Cancer Awareness March
    - f) Skin Cancer awareness May
  - Provide community education about early detection of various cancers including breast, ovarian, skin, lung, colon and prostate through periodic Health Beat column in the local newspaper.
- 3. Programs targeted to outcomes and quality of life for adult cancer patients
  - Continue to offer complementary therapies for cancer patients, survivors and caregivers such as therapeutic massage, meditative yoga, Pet Partners pet therapy and journaling.
  - · Continue to provide educational programs related to cancer survivorship.
- 4. Provide patient navigation for cancer patients to include resource/referral, follow-up in home, and networking with other agencies to improve health outcomes.
- $5. \ \ Provide \ dedicated \ resources to cancer community out reach through our oncology clinical social worker.$
- 6. Provide high quality oncology services and treatments including but not limited to; medical oncology, radiation oncology, clinical trials, brachytherapy and surgical interventions.
- Offerearly detection services including mammography, colonoscopies and low-dose CT screening for lung cancer.
- 8. Provide support to the American Cancer Society through Relay for Life.
- Provide ongoing funding to the Beaufort County Health Department Breast and Cervical Cancer Control program.

#### Initiative: Access to care

Goal: To improve access to health care especially for the uninsured/underinsured patient population.

#### Strategies:

- 1. Continued commitment to providing quality health care to everyone who seeks our services.
- 2. Continue to provide financial counselors who can assist with determining if patients qualify for Medicaid and in applying for other government-assisted programs.
- 3. Continue to offer charity care to our patients who are unable to pay due to financial hardships.

- 4. Collaborate with Vidant Medical Group to help recruit additional primary care and specialty providers to help keep care local.
- 5. Partner with Vidant Medical Group and local primary care practices as they work towards implementing the patient-centered medical home model of care which will provide greater access to needed services, better quality of care, greater focus on prevention, as well as early identification and management of health problems.
- 6. Serve as one of the lead organizations for Beaufort County 360, an alliance of community health agencies, schools, social service organizations and non-profits working to address the most critical needs in Beaufort County including access to care.
- 7. Provide representation on the Hyde Partners for Health committee.

# Initiative: Weight Management/Obesity, Physical Activity and Nutrition

**Goal:** To educate adults and children on the benefits of physical activity and nutrition and provide a wellness center with resources to improve general health and fitness.

## Strategies:

- 1. Provider height, weight, and body mass index screenings at community health events in Beaufort and Hyde counties for obesity prevention.
- 2. Serve on advisory councils and partnerships for health to promote wellness, health and fitness including Beaufort County Physical Activity and Nutrition Council, Beaufort County Healthy Eating Active Living (HEAL) Coalition, Hyde Partners for Health.
- Provide a medical model wellness center (that includes health risk assessment) for community (membership required) that offers exercise equipment, weights, and other exercise options as well as personal trainers, and consultation with exercise specialists to improve outcomes.
- 4. Offer wellness scholarships though the Tayloe-Ainsworth endowment for low-income community members on a sliding fee schedule or reduced membership rate based on need and health indicators.
- 5. Provide community education about a variety of topics related to wellness, nutrition, and physical activity through Health Beat column in the local newspaper.

- 6. Annually host at least one employee wellness challenge that targets weight loss and/or an increase in physical activity.
- 7. Promote healthy eating and educate employees and visitors on how to make healthy choices by providing all calorie information at the point of service at both of our hospital eateries. This will include all snack and vending machines. We will continue to offer a discounted rate on the healthiest entrées served in our hospital cafeteria.
- 8. To promote healthy eating, all hospital-sponsored functions (internal and external) where food is served will offer healthy options.
- 9. Utilize social media to provide information to the community about a variety of topics related to weight management/obesity, physical activity and nutrition.
- 10. Provide support and/or funding through our Community Benefit Grants and Health Initiatives program and other community partnerships that focus on physical activity and nutrition:

# Initiative: Mental Health/Substance Abuse

Goal: To improve access to services for mental health and substance abuse patients.

#### **Strategies**

- 1. Continue to provide an inpatient behavioral health unit.
- 2. Collaborate with Vidant Medical Group to continue to provide mental health services in the region through Vidant Behavioral Health with locations in Washington, Swan Quarter and Ocracoke.
- Provide comprehensive care management and transitional care program for low-income individuals diagnosed with both severe mental illness and chronic disease including care management, care coordination, primary care, and pharmaceutical assistance.
- 4. Participate on the Beaufort County 360 mental health task force.
- 5. Support Project LAZURUS in both Beaufort and Hyde counties
